


Alexei D. Voskressenski. Non-Western International **Relations Theories: Conceptualizing World Regional** Studies. Springer Global (Europe & America): Palgrave Macmillan. 2017. 270 p.

This book analyzes the concept of World Regional Studies as well as regional complexes, regional subsystems, and global regions. It explains the emergence of new phenomena in international relations and world politics on a regional and predominantly non-Western regional level. It tackles the following issues: How do non-Western societies react to the transformations of the global order? Is a non-Western democracy possible? Should we discuss the possibilities for the appearance of a non-Western IR theory or a new framework for analyzing de-westernized global development?

This book describes and analyses the influence of political culture on political processes in the Eastern world. It allows readers to make a comparative appraisal of the maturity of civil society in these countries as well as their specifics in political interactions and internal political competition seen through the eyes of a group of distinguished Russian researchers. It also explains why the onedimensional spread of democracy — completely negating or neglecting regional political-cultural specifics - may lead to war among civilizations instead of the formation of a more just and fair system of democratic governance.

The book explores ideas of how Europe, Eurasia. and Asia transformations may develop in the future focusing on transregional, regional integration, and regional projects - particularly Chinese. The volume employs a rigorous conceptual framework over a wide geographic range and applies different approaches to ask and answer challenging questions. The arguments presented in this book are built around the concepts of regionalism and transregionalism. 
